COVID UPDATES

Effective July 1st 2021, SVHS provided parents the option of changing letter grades to Pass/No Pass (P/NP) for the 2020-2021 school year as per CA AB104. Additionally, the school board adopted a modified graduation plan for students most severely impacted by the pandemic. Students from the class of 2023 and 2024 are eligible to graduate with a diploma after earning 180 credits versus the regular 220 credit graduation requirement. A small number of students have been able to register for SAT/ACT tests since the onset of the pandemic due to limited test site availability.

Community

Sonoma Valley is about 18 miles long covering 24 square miles. The City of Sonoma has a population of approximately 10,000, while the Valley itself exceeds 30,000. The Sonoma Valley Unified School District serves the educational needs of this agricultural community and is a tourism destination, equidistant to San Francisco and Sacramento. The District has a diversified economic base. Currently, the District consists of one comprehensive high school, one continuation high school, two middle schools, and four elementary schools utilizing a K-5, 6-8, 9-12 grade-level configuration.

Campus

Sonoma Valley High School is a comprehensive four-year public high school staffed by 65 teachers, 4.8 counselors, a .8 librarian and 4 administrators. The campus includes video production and photography laboratories, fine arts facilities, industrial arts shops, a state-of-the-art culinary facility, an agricultural farm, a theatre, three gymnasiums, four tennis courts, an all-weather track and practice fields and a new aquatic center. Student enrollment covers a wide spectrum of adolescents and includes high-achieving English Learners, special education, at-risk and disadvantaged youths. The school provides nine Career Technical Education Pathways in Agriculture, Arts and Media, Construction, Manufacturing, Engineering and Hospitality sectors, an AVID program which targets first-generation college-bound students from low socio-economic backgrounds, and a staffed College & Career Center which provides support for all students to be college & career ready upon graduation.

Extracurricular Program

Sonoma Valley High School offers a wide range of extracurricular activities including 28 clubs and 32 interscholastic sports teams. Visual and Performing Arts include: Art Design, Advanced Photography, Advanced Video Arts, Advanced Dance, Concert Band, Choir and Floral Design. The music, yearbook, newspaper, culinary arts, photography and video arts programs have been recognized, featured and honored at various events and venues. SVHS also boasts an agriculture farm where students have participated in FFA competitions winning awards including: State and National Degrees and Supreme Champion Awards.

Length of Semester/Day

The 180-day academic year is organized on a modified rotating block schedule with all classes meeting on Wednesdays. Thirty (30) credits per semester is the standard course load; students take six 90-minute block classes with two additional 45-minute intervention periods on Tuesdays and Thursdays and one 60- minute optional office hour period on Wednesdays.

Student class rank is determined based on a weighted academic grade point average (GPA). Beginning with Grade 9, all subjects, whether passed or failed, are included in the computation. A minimum of 220 credits is required for graduation. All Advanced Placement (AP) classes are weighted by one point.
